AIR CANADA

RESERVATION SERVICE FOR OTTAWA RESIDENTS— TRANSFER TO OTTAWA AIRPORT FROM MONTREAL

Mr. John Lundrigan (Gander-Twillingate): Mr. Speaker, my question is for the Minister of Transport and concerns Air Canada. Can the minister confirm that Air Canada has plans to transfer part of the company's information service to the Ottawa international airport and, if so, when will this take place?

AIRPORTS

PROVISION OF SUFFICIENT SPACE AND PROPER ORGANIZATION FOR SECURITY CHECK-OUTS

Mr. A. P. Gleave (Saskatoon-Biggar): Mr. Speaker, I have a question for the Minister of Transport which is supplementary to the question asked by the hon. member for Brant. What plans are in hand to establish space and proper organization within airports so that security inspections can be properly carried out with some comfort for passengers?

Hon. Jean Marchand (Minister of Transport): Mr. Speaker, I think I answered the question just a few minutes ago. As the hon. member knows, the bill to amend the Aeronautics Act will be before the House very soon. At that time we will have to work out with the airport authorities and the airline companies how we are going to implement the new act. The only authority there is now rests with the airlines themselves and not with the airport authority. We have no legal authority to carry out these inspections. In the meantime we have to rely on the right of the airlines to accept or refuse passengers on the basis of the private contracts they have with passengers. This is why there is this kind of confusion.
