SOYBEANS—DISCUSSIONS WITH UNITED STATES OFFICIALS—REQUEST FOR ASSURANCE OF ADEQUATE SUPPLIES FOR CANADIAN MILLS

Mr. Lorne Nystrom (Yorkton-Melville): Mr. Speaker, my question is a supplementary on soybeans and it is directed to the Minister of Agriculture. Has he been in contact with United States officials over the weekend and, second, can he now assure or give a guarantee to Canadian mills that they will have an adequate supply of soybeans?

Hon. E. F. Whelan (Minister of Agriculture): Mr. Speaker, our officials have been in contact as late as today with United States officials. As the Minister of Industry, Trade and Commerce has stated, the final figures are not available at this time but they should be shortly, today or tomorrow, so that we will know exactly what our needs may be and what the United States intends to do with long time Canadian customers of the United States for this product.

ALLEGED HARASSMENT OF PASSENGERS AT AIRPORTS— REQUEST FOR STATEMENT ON AUTHORIZATION FOR ACTIONS

Mr. Otto Jelinek (High Park-Humber Valley): Mr. Speaker, my question is for the Solicitor General who is absent from the House today. However, I understand from his office that the Minister of National Health and Welfare will answer my question. In the light of the fact that there have been numerous reports of ground transport harassment by RCMP personnel at both the Toronto airport terminals, and because the RCMP have in fact been causing a great deal of inconvenience to many passengers at the airport, could the minister advise the House what regulations the RCMP are supposed to be enforcing regarding the airport limousine concession, as well as the loading and unloading of passengers and luggage? Who, in fact, is responsible for these regulations being implemented—

UNEMPLOYMENT INSURANCE
