Oral Questions

INQUIRY WHETHER GOVERNMENT APPROVES HON. LAURIN'S STATEMENT ON EDUCATION OF OFFICIALS' CHILDREN

Mr. Irénée Pelletier (Sherbrooke): Mr. Speaker, my question is directed to the Acting Prime Minister. Following last Saturday's visit in the Eastern Townships of Quebec Cultural Development Minister Camile Laurin, and his statement regarding the federal decentralization program to the effect that the government of Quebec would be willing to give federal civil servants coming into Quebec six years during which they could send their children to English schools, could the Acting Prime Minister tell the House if he has read the text of Mr. Laurin's statement and if the federal government agrees with that suggestion?

Hon. Jean Chrétien (Acting Prime Minister): Mr. Speaker, yes I have read Mr. Laurin's statement. Regarding the move to Sherbrooke, our request that the Quebec government allow public servants affected by that move to send their children to English schools is the same as the request we make to other provincial governments whenever there is decentralization: we require that they provide French education to public servants moving to their cities. The request is the same for the province of Quebec as for all other provinces; furthermore the move will not occur for another six months. It is the government's intention to decentralize over a long period of time and public servants have the right to send their children to schools teaching in their mother tongue if they want, otherwise, pursuant to the commitments given to the House, we will not allow decentralization.
