## STATUS OF WOMEN

REVIEW OF ADVISORY COUNCIL'S OPERATIONS

Miss Pauline Jewett (New Wesminster-Coquitlam): Madam Speaker, I have a question for the minister responsible for the status of women.

An hon. Member: Good luck.

Miss Jewett: Last week, on Thursday, I believe, the membership of the review panel decided to conduct a review of the council's operations. The panel consists entirely, with one exception, of people who were themselves involved in those shenanigans. I wonder if this kind of internal review, being judge in one's own cause, constitutes, in the eyes of the minister, the independent external review he promised about a month ago to Canadian women?

Hon. Lloyd Axworthy (Minister of Employment and Immigration): Madam Speaker, as I have told the hon. member and other members of this House many times before, I think it is incumbent upon members to respect the autonomy and independence of the council and to allow it to make decisions concerning its own affairs.

Miss Jewett: Madam Speaker, the minister himself recognized the autonomy and independence had been undermined—

Mr. Crosbie: He undermined it.

Miss Jewett: —by himself and others, and that is why a month ago he promised Canadian women that there would be "an independent external review of the advisory council". When is the minister going to have that independent external review?

Mr. Axworthy: Madam Speaker, the hon. member is wrong in her assertion. In a meeting with a number of representatives of women's groups, I undertook to discuss the question of a
