INCREASE IN PRICE OF FUEL—EFFECT ON CONSUMERS

Mr. Geoff Scott (Hamilton-Wentworth): Madam Speaker, my question is for the Minister of Consumer and Corporate Affairs. Given the fact that the price of gasoline at the pumps during the year 1980 rose approximately 32½ cents per gallon—I am not using the metric smokescreen of litres; the price went up approximately 32½ cents a gallon during the year 1980, which is just an estimate, it may be higher—and given the fact there is the prospect of at least another 12 cents a gallon increase at the pumps, and a similar increase for home heating fuel, as a result of this acquisition of Petrofina by Petro-Canada, can the Minister of Consumer and Corporate Affairs tell me where his concern for the consumer is now? Does the minister have anything to say to the consumer about these increases?

FRASER RIVER, B.C.—PROPOSALS CONCERNING CLOSURE

Miss Pauline Jewett (New Westminster-Coquitlam): Madam Speaker, I have a straightforward question for the Minister of Fisheries and Oceans. At a meeting I attended last Thursday in Vancouver, held by the Fraser River fishermen and others, it was made abundantly clear that the minister had not consulted them prior to initiating this drastic proposal concerning the closure of the Fraser River and other restrictions to commercial fishermen. Will the minister assure me and all members in this House from British Columbia that he will consult with the Fraser River gill-net fishermen this week before there is any decision on the part of the government to implement these drastic proposals concerning the Fraser?

Hon. Roméo LeBlanc (Minister of Fisheries and Oceans): Madam Speaker, if the member would read the answer which I gave with respect to this matter yesterday, she would see these were, in fact, discussions which took place. There is a process in the British Columbia fishery called "the expectations for the coming year". We discuss with fishermen's groups what appears to be the promise of this or that fishery in this or that river. This is a normal process which has been going on for many years.

With respect to chinook stocks in the Fraser, which are badly depleted, we have been taking conservation measures. We have announced some of these measures. I made it clear yesterday that if there are to be strict measures implemented, then all groups in the fishery must share, and in this I include the sport fishery as well.
