The first motion is made on the suggestion of my friend, the Member for Ottawa—Vanier (Mr. Gauthier).

Mr. Speaker, on behalf of the Right Honourable Prime Minister, I move:

That the Speaker of the House of Commons convey to the President of the French National Assembly and to the President of the French Senate the good wishes of the Canadian House of Commons on the occasion of the official ceremonies which will commemorate in July the bicentenary of the French Revolution and of the *Déclaration des droits de l'homme et du citoyen*.
