## VIA RAIL

#### PERSIAN GULF

Mr. Nelson A. Riis (Kamloops): Mr. Speaker, I have the pleasure to present another petition on behalf of a large number of British Columbians, particularly from the communities of Kamloops, Salmon Arm and Sorento, who point out a number of concerns regarding the situation in the gulf as it has occurred and as it is unfolding. They are asking for Canada's participation in a most positive way in the post-conflict period.

### GOODS AND SERVICES TAX

Mr. Francis G. LeBlanc (Cape Breton Highlands—Canso): Mr. Speaker, I have several sets of petitions today. The first set of petitions comes from constituents in my riding of Cape Breton Highlands—Canso, concerning the goods and services tax which my constituents still feel is an onerous and unfair tax and they wish to make Parliament aware of their ongoing opposition to this tax.

The petitioners are from West Arichat, St. Peters, and various places in my constituency. They wish to register their ongoing opposition to this tax.

### VIA RAIL

Mr. Francis G. LeBlanc (Cape Breton Highlands—Canso): The second petition concerns the elimination of VIA passenger rail service from Truro to Antigonish, Nova Scotia. The petitions come, first of all, from the students of St. Francis Xavier University, who are opposed to the government's decision to abandon VIA Rail passenger service. They point out that since that passenger rail service was abandoned over a year ago, the transportation needs of the students are much more difficult to meet. It is a burden on students in the area who want to leave on weekends because the alternatives to passenger rail transportation are much more expensive.

Another group of petitions concerning VIA Rail passenger service comes from the town of Antigonish. The residents of the town of Antigonish, more than one year after the elimination of this service, are still opposed vigorously to the government's decision and have shown up in large numbers to express their concerns by signing a petition to that effect.
