DOCKSIDE MONITORING PROGRAM

Mr. Francis G. LeBlanc (Cape Breton Highlands—Canso): Mr. Speaker, two weeks ago the fisheries minister announced the removal of all federal government support for the dockside monitoring program as of May 31 as part of a whole package of administrative changes.

The dockside monitoring program enforces quotas assigned to fishermen through the observation and weighing of catches as they are landed. This program is generally viewed as helping achieve a fair application of the individual quota system and provide reliable and detailed stock information.

Yet the minister has made a mess of the whole program. As before, fishermen who can ill afford it will be forced to pay the costs of the program through user fees. Just about everyone is confused about the host of other program changes announced, including the minister's own officials who seem unable to explain the new program to fishermen.

I urge the minister of fisheries to take immediate steps to explain and clarify this new program and to maintain the present program and federal funding past May 31 until the changes are fully understood by fishermen.
