With the arrival of the Harrison iner Centurion, Capt. Maycock, in port a few days ago, the passage of th first Centurion to the waters of the George Anson, the celebrated English

fordshire, entering the navy in Februa ary, 1712. By rapid steps he became ieutenant in 1716, commander in 179 and post captain in 1724. In this rank he served twice on the North American squadron as captain of the Scar orough and the Squirrel from 1724 1730, and from 1733 to 1735.

In 1737 he was appointed to the Centurion, a vessel of 60 guns, on the eve of the war with Spain, and when hostilities had begun he was chosen to mmand as commodore the squadron which was sent to attack her possessions in South America in 1740. The original scheme was ambitious and was not carried out. Anson's squadron o six ships which sailed later than was intended, was very ill-fitted, and was reduced by successive disasters to his lagship the Centurion.


