On motion of Mr. Partelow,

Resolved, That an humble and dutiful Address of Condolence be presented to His Majesty, on the death of His late Majesty King George the Fourth, and of congratulation on His present Most Gracious Majesty's accession to the Throne of His Ancestors.

Ordered, That Mr. Partelow, Mr. End, and Mr. Hill be a Committee to prepare the Address.

Mr. End, by leave, presented a Petition from Pcter Joseph Dollar, of Tracady, in the County of Gloucester, praying compensation for teaching a School at that place; which he read.

Ordered, That the said Petition be received and referred to the Committee of Supply.

Mr. S. Humbert, pursuant to leave, brought in a Bill, to alter and amend an Act, intituled, "An Act to repeal all the Acts now in force relating to the Light House upon Partridge Island, and to make Provisions for the future support thereof, and of other Light Houses at the entrance of the Harbour of Saint John." Also,

A Bill for the facilitating the recovery of the wages of Seamen in the merchant service and coasting trade of this Province.

Which Bills were severally read a first time.

Mr. J. Humbert, by leave, presented a Petition from William H. Nase, of Westfield, in King's County, praying further compensation for damage sustained in consequence of an alteration made in the Nerepis Road, by leading the same through his improved land.

Upon the question, that it be received and referred to the Committee of Supply, it was decided in the negative.

The House, according to the order of the day, went into Committee of the whole, on a Bill to regulate Inns, Taverns, and Houses for selling strong or spirituous Liquors, and to repeal all the Laws now in force relating to the same.

Mr. J. Humbert in the Chair of the Committee.

Mr. Speaker resumed the Chair.

The Chairman reported, that having gone into consideration of the Bill referred to them, they had made progress therein, and that he was directed to ask leave to sit again.

Ordered, That the report be accepted, and leave granted.

Mr. S. Humbert, by leave, presented a Petition from John Ward, Esquire, and others, Inhabitants of the City of Saint John, praying an Act may pass to regulate the fees of Attornies and others, in the Supreme Court, and other Courts in this Province, and also to extend the Jurisdiction of the Courts of Common Pleas; which he read.

Ordered, That the said Petition be received and lie on the Table.

Mr. Brown moved for leave to bring in a Bill in addition to an Act passed in the twenty-sixth year of the Reign of His late Majesty King George the Third, intituled, "An Act for the appointment of Town or Parish Officers in the several Counties in this Province."

The said Bill being brought in, was read a first time.

Read a second time the following Bills :---

A Bill to empower the Owners of the Saw Mill at the Rolling Dam, on the Digdeguash River, in the County of Charlotte, to erect a Boom for securing Saw Loge on the said River.

A Bill to prevent the destruction of Moose on the Island of Grand Manan.

A Bill to amend the Act to incorporate sundry persons by the name of the Saint John Marine Insurance Company. And,

A Bill to alter and amend an Act made and passed in the fifth year of His late E Majosty's
