wars and sacrifices, that it is definitely essential to unite if we want final peace, would it be logical for a country like Canada, which is only at the beginning of a wonderful destiny, to disunite because of pointless quarrels which could be settled with a little goodwill and mutual understanding.

Mr. Chairman, those who advocate separatism are working against the best interests of Canada. They forget in particular the sacrifices made during the two world wars by Canadians who went to the battlefields to defend not a foreign cause but the cause of freedom, the cause of Canada which some of them cherished even more than their lives.

Canada has to be united. It is essential for Canadians to find, through the representatives they have elected to parliament to give them guidance and unity, formulas which will bring about mutual understanding. Canadians must unite, and that objective will be achieved only when Canadians will have understood that the role which is reserved for French Canadians, in this Canadian land, must have the same importance on the federal scene as well as in private enterprise, as the one which is entrusted to English Canadians or other racial groups living in this country.

Our English speaking colleagues must understand not only our problems, but also the fact that we, French Canadians, are here to stay, that we are deeply attached to our French traditions and that we wish to keep on speaking this language which is our mother tongue, and one of the most beautiful in the world. English Canadians must understand the need which French Canada has of maintaining its cultural tradition, because it is only through the maintenance of that cultural tradition that the citizens of French Canada will fully develop.

On the other hand, French speaking Canadians must understand that there exists among their English speaking colleagues a desire to understand them, to be conciliatory and to sit down with them around a conference table, in order to find the formulas which may bring about good understanding between all groups.

Mr. Chairman, I am of the opinion that this debate is necessary.

BROADCASTING**REQUEST FOR SURVEY OF COMMERCIAL ADVERTISING ON RADIO AND TELEVISION**
