For my part, I am surprised that the province should have enough money to concern itself with things that do not fall within its jurisdiction. If it has millions of dollars to invest in the field of satellites, I am convinced that the Minister of Finance will be pleased to hear about it.

I did not ask the Prime Minister whether the stage had been reached for a tripartite agreement, but whether he would favour the idea?

Mr. Speaker: The question then becomes hypothetical.
