- Mr. Jean-Charles Cantin (Parliamentary Secretary to Minister of Trade and Commerce): 1. For census purposes, a census metropolitan area is defined as an urban agglomeration of at least 100,000 persons, of which 50,000 or more live in the central city. Fringe communities to be considered part of the metropolitan agglomeration must be in close geographic, social and economic relationship to the central city.

To determine these relations, such criteria as distance from the central city, the extent of build up areas with a population density of 1,000 persons or more per square mile
