Mr. Speaker: Stand.

In so far as the Department of Manpower and Immigration is concerned the motion is not acceptable because the requested papers reflect on the personal competence or character of an individual and are also private or confidential and not of a public or official character. I would therefore ask the hon, member to withdraw his motion.

Reid (Parliamentary Secretary to President of the Privy Council): Mr. Speaker, this motion is unacceptable to the government because Trident Steamships Limited was incorporated provincially and no source exists in the federal government for determining the ownership of this company. I would therefor ask the honmember to withdraw his motion.

Mr. Beattie (Hamilton Mountain): Agreed.

Mr. Speaker: The motion is dropped.

NEWFOUNDLAND STEAMSHIPS LIMITED—OWNERSHIP
PARTICULARS

Mr. John M. Annual returns submitted to the Department of Consumer and Corporate Affairs under the Canada Corporations Act and the Corporations and Labour Unions Act indicate officers and directors but not the ownership of companies. I would therefore ask the hon. member to withdraw his motion.

Mr. Beattie (Hamilton Mountain): Transfer for debate.

Mr. Speaker: Transferred for debate.

Mr. Reid: Mr. speaker, I ask that the other notices of motions be permitted to stand.
