Second, does the minister intend to reinstate the milk subsidy on fluid milk? If not, does he intend to consult with his colleague, the Minister of Consumer and Corporate Affairs, to find some new method of bringing relief to hard pressed Canadian consumers?

Hon. E. F. Whelan (Minister of Agriculture): Mr. Speaker, I made several statements in the House on behalf of the government on the consumer milk subsidy and as to our intentions. The spending of the government has been criticized by members of the opposition and by the public, but over half of our increased spending is to take care of people whose incomes do not allow them to look after themselves in the fashion we want. Therefore, we increased the social benefits. The dairy policy will be announced before the first of April.
