- 3. Were Abdul Rahman Khadr and Avis Hassanien of the Egyptian Trade Union movement detained at Dorval Airport on June 11 and, if so (a) for how long (b) what was the reason for their delay and prolonged interrogation?
- 4. Is it government policy that no Egyptian citizens may enter Canada without exceptional inquiry and interrogation?
- 5. Was Fayez Sayegh detained at the Toronto International Airport when he came to Canada as a guest of the Canadian Arab Federation on May 18 and, if so (a) for how long (b) what were the reasons for such detention and delay?

Hon. Robert K. Andras (Minister of Manpower and Immigration): 1, 3 and 5. No. Every person seeking to come into Canada must first appear before an immigration officer at a port of entry for examination as to whether he is or is not admissible to Canada. The time taken for such an examination depends upon the circumstances concerning individual cases. In the instances referred to in parts 1, 3 and 5, there was no undue delay.

2. Ministers Permits are issued to persons who, for one reason or another, are unable to comply with certain portions of the Immigration Act or Regulations but whose temporary admission would pose no threat to Canada's national security or health. Issuing of Ministers Permits is in no way influenced by an individual's country of residence or citizenship.

EXCISE TAX ACT

RULING BY MR. SPEAKER ON BILL C-66

Mr. Baldwin: Mr. Speaker, may I rise on a point of order before Your Honour delivers your ruling? I understood from reading what you said yesterday that you thought the bill and the ways and means resolution should be brought closer together, hopefully without prejudice to the progress of the bill. I am just paraphrasing what Your Honour said as recorded at page 7550 of Hansard. Mr. Knowles (Winnipeg North Centre): Mr. Speaker, on the same point of order, I felt when the President of the Privy Council (Mr. Sharp) made his statement a moment ago that each of us should be allowed at least a brief sentence. It is true that we had meetings and we were unable to come to an agreement, but this is a two-way proposition. We were not able to agree to the proposition put before us by the President of the Privy Council, but we made a proposal to which he was not prepared to agree.
