PROPOSAL RESPECTING AUTOMATIC JOINT CUSTODY OF CHILDREN

It is from the organization for the protection of children's rights of Canada. It proposes to implement a new law in Canada involving automatic joint custody of children unless individual circumstances warrant otherwise.

Mr. Jean-Robert Gauthier (Ottawa-Vanier): Mr. Speaker, I have four petitions which protest to this House Bill C-47 and Bill C-48. They support the aims of Mr. Ricardo DiDone, which are the education of new generations in school on the responsibilities of marriage, compulsory mediation prior to divorce and so on. These four petitions represent Canadians from Cowansville, Granby, Montreal and other places in Quebec.

Mrs. Sheila Finestone (Mount Royal): Mr. Speaker, I have in front of me several thousand names and hundreds of petitions. I do not intend to read all the names—do not get frightened, Mr. Speaker, I do not intend to do that. However, as I was looking at these petitions which arrived in my office over the five or six days, I thought it would be of interest to note that there is not just one language, English, represented, or one language, French, but a multitude of languages such as Italian, Greek and Arabic. I found that so fascinating that I would like to bring to your attention that the lack of the kind of humanizing changes in our divorce Bill is creating great anguish among many parents, particularly—

Mrs. Finestone: I wish I could. Every language is a new window on the world, Sir, and if I could read it, I would, with pleasure.

An Hon. Member: Right on.

Mrs. Finestone: As a result of that particular suggestion, Mr. Speaker, I will read the petition. We protest Bill C-47 and Bill C-48 dealing with divorce and children of divorce where two parents are forced to attack one another in order to win a child, an act that is totally inhumane and unacceptable. Wherefore the undersigned, your petitioners humbly pray and call upon Parliament to support the aims of Mr. Ricardo DiDone which are, the education of responsibility in marriage in school for new generations, to require compulsory mediation prior to divorce, to support shared parenting as a concept, to ensure the right of children to communicate with the non-custodial parent, that both parents have access to anything that is pertinent to the wellbeing of the child, and last, but not least, if not respected with valuable reason that custody may be reversed when it goes back to the court.
