Mr. *Yeo*—On Monday next—ORDER OF THE HOUSE for a Statement giving the names of the Employés on the Intercolonial and Prince Edward Island Railways; giving also, the respective Salaries paid to each.

Mr. *Massue*—On Wednesday next—ORDER OF THE HOUSE for a Statement shewing the Lands held by the Government in the Town of Sorel, the extent thereof and the Revenue since the 1st July, 1867.
