REACTOR SAFETY ADVISORY COMMITTEES

Question No. 2,381—Mr. Douglas (Nanaimo-Cowichan-The Islands):

- 1. What is the extent of Atomic Energy Control Board's independent expertise necessary to evaluate the reliability of the ECCS?
- 2. Have the AECB or its Reactor Safety Advisory Committees ever questioned the ability of the ECCS to prevent fuel failures?
- 3. Have AECL or Ontario Hydro answered satisfactorily all questions concerning the ability of the ECCS to prevent fuel failures?
- 4. If all of the radioactive gases and volatile substances from a single failed fuel bundle were to escape into the atmosphere surrounding the plant, what would be the maximum possible health effects (per thousand) among the surrounding population within a radius of (a) ten miles (b) five miles (c) two miles?
- 5. In the event of a loss-of-coolant accident in a CANDU reactor, assuming that the ECCS works as planned, can it be categorically asserted that no fuel failures will occur?
- 6. In the event of a loss-of-coolant accident in a CANDU reactor, assuming that all other safety devices function properly, what would be the probable consequences to the reactor if the ECCS were unavailable for any reason?
- 7. Is it considered possible that steam binding could prevent the ECCS from functioning as planned and, if not, for what reason?
- 8. Has the ECCS been tested under realistic operating conditions?
- 9. In the event of an inlet header rupture without emergency cooling, what would be the probable consequences in terms of the release of fission products from the fuel bundles?
- 10. Is the WR-1 reactor at the Whiteshell Nuclear Research Establishment protected against an inlet header rupture and, if so, in what way?
- 11. In the event of a loss-of-coolant accident in a CANDU reactor, what would be the probable consequences of a failure to scram?
