FOR TRUCKS AND TAXIES.

Now basic license tags are being issued to all trucks and taxies operating in this city, and must be had on application. City staffs will be law calling for the display of these tags on all licensed vehicles, and a distinct tag is issued for each class. Robert Timis, the city inspector, is now busy checking up these licenses, which must be taken out May 1 each year.

Captain Sharp was at one time in command of the Canadian Voyager.

STAFFING CONTINUING.

Owing to the rapid shrinking in the public works appropriation, Commissioner Frink stated yesterday he would, notwithstanding the unemployment situation, be obliged to curtail the staff of workmen employed by his department. He said the sum of \$15,000 a month was being expended on public works. Work now being done by this department includes paving of streets, sidewalk, between Charlotte and Queen streets, new walls will be built. Building is being reset on Prince William street, and on Main street, the new retaining wall built there last year.

WILL PROVIDE WORK.

In reply to a request for relief from the unemployment prevailing in the districts of Miramichi and Edmundston, Mr. Daniel, Minister of Public Works, said it is possible that tenders will be called for the removal of the South Bay bridge and its replacement by an embankment and culvert. Such work would afford considerable employment to the unemployed here, he said. To the question of how long the work will last, Mr. Veniot said he would give the matter his careful consideration.

DR. J. H. BARTON, OF LANCASTER, IS OPPOSITION CANDIDATE

Convention in Seamen's Institute Most Representative Ever Met for a Selection—Every Parish and Polling District Represented—Hon. J. B. M. Baxter and J. D. Palmer Enthusiastically Received With Other Speakers.

Dr. J. H. Barton, of the Parish of Lancaster, was the unanimous choice of the Opposition convention, held last evening at the Seamen's Institute, Prince William street, to choose a candidate to contest the constituency in the by-election made necessary by the resignation of Hon. J. B. M. Baxter, M. P., and judging from the enthusiasm shown he will have no difficulty in carrying the banner of the local Opposition party to victory.

The convention, the first one of the bart attended and most representative ever met to select a candidate for the county, every parish and polling district being represented, and each and every delegate was full to the brim with the feeling that victory was in the offing. The people were only waiting for an opportunity to express their protest against the wasteful administration of the Foster-Veniot combination, who have been misgoverning the Province for far too long. Hon. J. B. M. Baxter, M. P., and J. D. Palmer, leader of the Provincial Opposition party, were present and were given a most hearty reception by the delegates.

Dr. Barton, the candidate, is a man well known and highly respected in the city and county. He was born in the city and for the past few years has made his home in Lancaster. "He was always taken an active interest in community matters and at the time of his election to represent the St. John Power Boat Club. He is prominent in the Masonic fraternity and in the order of Knights of Pythias.

The convention was called, ordered by Thomas B. Carson, who asked for nominations for the offices of chairman and vice-chairman and treasurer of the opposition, with Theodore Martin as secretary.

G. Marie Logan proposed a resolution endorsing the leadership of J. D. Palmer, and expressing appreciation of the work of Charles D. Michaud as House leader in the last session. This was seconded by Hon. James B. Cameron and carried unanimously.

The convention closed with the National Anthem.
