Hon. Mr. Connolly (Ottawa West) moved that the bill be placed on the Orders of the Day for second reading at the next sitting.

Hon. Mr. Brooks: Honourable senators, I do not wish to object, but it seems to me that we are placing a lot of bills on the Order Paper for the next sitting. As honourable senators know, we have all just returned to the Senate and it is rather difficult to pick up the loose ends, as it were. I am wondering whether we are not trying to do more than we really should in so short a time. I take it that some of the bills will be stood.

Hon. Mr. Connolly (Ottawa West): Most of them will be stood. May I say to the Leader of the Opposition, the purpose of moving as I have is simply to get the bills on the Order Paper so that we can proceed and be selective about them.

Hon. Mr. Brooks: With that assurance, I am satisfied.

Motion agreed to.

THE LATE HON. THOMAS V. GRANT

TRIBUTES

Hon. John J. Connolly: Honourable senators, at this time may I ask for unanimous consent to refer to the death since we last met of Senator Grant of Prince Edward Island.

I am sure that it is unnecessary to repeat what was so eloquently said of Senator Grant's career at the time of his retirement on January 19 last year by the then Leader of the Senate, Senator Bouffard. He spoke not only of Senator Grant's retirement from the Senate but referred to his career and mentioned his family, his service in the Legislature of Prince Edward Island, his service in the House of Commons from 1935, and his service in the Senate from 1949 until the time of his retirement.

I am sure that I express the views of all honourable senators when I say here on your behalf that we extend our deepest sympathy to Mrs. Grant and the surviving members of Dr. Grant's family.

Hon. A. J. Brooks: Honourable senators, I concur entirely in the remarks of the honourable leader, and on behalf of the Opposition I also express sympathy to Mrs. Grant and the family.
