

formed by the Treasury Board Secretariat and the Unemployment Insurance Commission as follows: 1. With reference to "lay-off" procedures pertaining to the Public Service Employment Act: (a) An employee laid off from the Public Service is entitled to all the benefits of the Adult Occupational Training that apply to any unemployed person. These include occupational training; (b) The Adult Occupational Training Act provides for training allowances. Furthermore, Public Service employees when laid off, depending upon their status under collective bargaining, are entitled to either severance pay or retiring leave. Most collective agreements signed to date provide for severance pay equivalent to up to 28 weeks' pay, depending on length of service. For other employees, there is provision for up to 26 weeks' retiring leave on full pay under the Public Service Terms and Conditions of Employment Regulations.

2. Not applicable.

3. The coverage of employment in the federal public service is now permitted, under Unemployment Insurance Regulation No. 70, for employees who have not been declared permanent. The advisability of revising the unemployment insurance program is being studied, and the status of employments now excluded from the Act will be reviewed as part of this study.

There were 32 routes emanating from the following 31 post offices: Clontarf, Corkery, Dorland, Fairfield East, Fallbrook, Halloway (R.R.1 & R.R. 2), Lonsdale, Rankin, South Monaghan, Wemyss, Anten Mills, Cresswell, Duncan, Dunedin, Rathburn, Riverview, Aberfeldy, Belton, Crinan, Eden Grove, Greenock, North Bruce, Ostrander, Pinkerton, Science Hill, Walkers, Alderdale, Eau Claire, Ice Lake, Ophir, Rydal Bank.

\$28.03 per annum was the average cost per rural route patron for the 31 offices concerned.

\$24.27 per annum is the national average cost for offices where letter carrier delivery service is provided.

\$26.18 per annum was the average cost per rural route patron for the offices concerned.

All postmasters were notified of the closing of their offices and no severance pay was required.

Nine contractors received severance pay totalling \$1,028.03.
