EXPENSES AT ASSEMBLY. Toronto Presbytery Agree to Certain

Recommendations.

Toronto, Jan. 76.—At the last meeting of the Presbytery of Toronto, Rev. mittee appointed to deal with the remit from the synod committee re assembly expense fund, reported the following recommenedations:

"That the Presbytery reconsider its ley 512, Hendry 460. decision in reference to the percentage of representation, in view of the great expense which would be incurred in paying the expenses were the percentage continued at one-fourth, and recommend that it be reduced to one-

That a fund be instituted to meet the traveling expenses of members of assembly, the expenses being understood to mean the necessary actual outlay for traveling to and from the place of meeting, and shall not include sleeping-car or state-room fares, or meals by the way, cabs, etc.
"That this fund, to be known the assembly commissioners' fund, be distributed by a small committee, to be appointed annually by the General

"That the committee shall, prior to Jan. 1 form an estimate of the total sum required, and apportion the said sum among the Presbyteries of the church on an equal basis as equitably

"That Presbyteries be instructed to take such steps as to them seem most desirable to secure the amount ap portioned, and forward the same to the treasurer of the assembly commissioners' fund prior to the 1st of

"That commissioners present to the treasurer prior to the evening seder-unt of the third day of the assembly's sitting a statement of their traveling "That the committee make an equit-

ceived, and that the full traveling expaid whose Presbyteries have forwarded the full amount apportioned to the committee."


