FOREIGN INTELLIGENCE.

FRANCE.

Paris, April 27 .- The southern forts are badly damaged. Versailles projectiles fall inside the ramparts of the city. A great many people have been killed and wounded. M. Thiers announced in a circular that active operations commenced yesterday. Forts Vanvres and Issy were fired on, and it is presumed the latter will soon be silenced.

The Temps proposes that Paris shall elect delegates to decide whether civil war shall continue or cease. It also proposes that a new Commune be elected according to the law passed at Versailles, to treat for the maintenance of the Republic, Municipal liberties in Paris, and a general amnesty.

The Mot d'Ordre says the Communists will blow up the forts if it should become a neces-

The Commune announces that it has made arrangements for the ample provisioning of Paris, and that prices will speedily fall.

An official statement of the losses of the Communists up to Thursday sum up 9,000 in killed and wounded, besides 3,000 prisoners.

The Mot d'Ordre alleges that the people of Toulouse have risen in insurrection and that many of the streets are filled with barricades.

The Reveil says the daily revenue of the Commune averages six hundred thousand franes, and is sufficient to provide for the men under them and the conduct of the war.

A delegation from Lyons appeals to the Assembly and Commune to cease their fratricidal strife.

The Sociale, a new evening journal, demands that the Commune shall proclaim the abolition of inheritance. The Cri du Peuple applauds this project.

It would appear from the last of the many circulars which have been published by M. Thiers that the greater portion of the army which was forced to surrender at Metz has been concentrated and recognized, and will immediately take part in the great operations against the communists of Paris, which are expected to bring the hideous antics of insurgents to a disastrous close. Startling news may soon be anticipated consequently from the beleaguered capital, the drama being about to end in a whirlwind of fire and blood.

It is now admitted that government is unable to pay the Germans the first instalment on the indemnity long since due.

ITALY.

ROME. - THE POPE'S ANNIVERSARY. - I hear on reliable authority that at least 50,000 persons have announced their intention of coming in pilgrimage to Rome for the 16th of June, should our Holy Father be, in God's mercy, spared so long to the Church, of which, humanly speaking, there is every hope. They will do well to notify their intentious to their respective Governments, and to provide themselves with regular passports, as the Italian Government is already taking alarm at the movement, and is prepared, through its faithful allies, the Garibaldians, to give the pilgrims every sort of annoyance, as it did for the Centenary of 1867.—Corr. Tublet.
