

**Civil Service Act, Amendment, bill:**

Resolution,—To provide for veterans' preference; increased salaries to the Commissioners; statutory increases to temporaries, etc.; House to go into Committee on, 436. Resolution agreed to, after debate, 712. Bill No. 413 (Mr. Gibson, Hamilton West)—An Act to amend the Civil Service Act; 1st R., 712. 2nd R., 729. Reported without amendment, 729. 3rd R. moved, 735. Amendment (Mr. Bentley)—to refer back to Committee of the Whole to give veterans' preference to merchant seamen, 735. Amendment ruled out of order as involving expenditure of public money, and issued instructions that the Committee do certain things which it could already do, 735. Ruling appealed and sustained (yeas 93; nays 76), 735. 3rd R., 736. Passed by Senate, 907. R.A., 999. 11 George VI, Chapter 53.
