INDIAN AFFAIRS

GRAND RAPIDS, MAN .- REPORTED NON-PAYMENT OF AGREED WAGES

Mr. Hubert Badanai (Fort William): Mr. Speaker, I wish to direct a question to the Minister of Citizenship and Immigration arising out of a Canadian Press report dated January 27-

Some hon. Members: Question.

Mr. Badanai: -concerning protests by Indians at Grand Rapids, Manitoba, to the effect that they are not receiving the wages promised by the Drake Construction Company of Winnipeg. Can the minister inform the house whether her department has made any attempt to protect the rights-

Mr. Speaker: Order. If I understand the hon. member's question correctly it relates to the payment of wages by a construction company, which surely is not any part of the administrative responsibility of the department.

[Later:]

Mr. Badanai: I wish to ask a question of the Minister of Citizenship and Immigration. Has the hon, lady received any representations from the Indians of Grand Rapids, Manitoba, regarding their wage difficulties with the construction company for which they work?

Mr. Speaker: A question about the receipt of a communication should, of course, be of sufficient importance to warrant its being asked. However, I think I might permit a reply to be made.

Hon. Ellen L. Fairclough (Minister of Citizenship and Immigration): No representations have been made by the Indians to my department. I would point out to the hon. member that the group concerned in the incident to which he refers includes many metis and people not of Indian blood. In these circumstances the whole matter is being handled by the provincial department concerned. However, in an effort to protect those Indians who are to some extent the responsibility of my department, we have been in constant consultation with the authorities of the province of Manitoba.
