**ADMINISTRATION OF JUSTICE****INDEMNIFICATION OF FAMILIES OF VICTIMS OF CRIMINAL ACTS**

On the orders of the day:

**Mr. Auguste Choquette (Lotbinière):** Mr. Speaker, I should like to put a question to the hon. Minister of Justice and Attorney General.

Since a number of honest citizens think that our society makes many efforts to improve the lot of criminals, I should like to ask the minister the following question.

Is he giving consideration to setting up or interesting the provinces in setting up a program of compensation for crime victims of the families of crime victims?

**Hon. P.-E. Trudeau (Minister of Justice):** Mr. Speaker, this question has also been raised by certain correspondents. I am studying the problem at the present time. As the hon. member is aware, there is also here a question of constitutional law, for such compensation could come from the provinces instead of the central government. However, in that case, negotiations could be undertaken with the provinces.

**WINTER WORKS****REQUEST FOR EARLY ANNOUNCEMENT OF 1967-68 PROGRAM**

On the orders of the day:

**Mr. Jack A. Irvine (London):** I should like to direct a question to the Minister of Manpower and Immigration. I am wondering when the minister might be prepared to announce the plans of his department respecting the winter works program for the year 1967-68.

**Mr. Speaker:** Order. I am wondering whether the matter is so urgent that the question should be asked at this time. I have serious doubts about it.

**Mr. Irvine:** On the point of order, Mr. Speaker, this is very important because the municipalities must make their plans and set up their budgets for this purpose. I believe on that basis it is very important the announcement should be made right away.

**Hon. Jean Marchand (Minister of Manpower and Immigration):** I believe last year the announcement was made during the course of the month of July. I am hoping that this year it will not be later than that.
