EXTERNAL AFFAIRS

DISARMAMENT—INQUIRY AS TO RECONVEN-ING OF GENEVA CONFERENCE

On the orders of the day:

Mr. Andrew Brewin (Greenwood): Mr. Speaker, I have a question for the Secretary of State for External Affairs. I understand that the 18-nation disarmament conference is reconvening at Geneva and that the President of the United States has urged all the nations concerned to move quickly toward a treaty for the non-proliferation of nuclear weapons. Is Canada taking any steps or initiative in this regard?

Hon. Paul Martin (Secretary of State for External Affairs): Mr. Speaker, as the hon. gentleman has said, this morning the disarmament committee opened its proceedings in Geneva. Yes, Canada has been actively engaged in consultations with certain countries, with the expectation that there will be tabled during the disarmanent committee meetings a draft proposal for the non-proliferation of nuclear weapons. I believe I can say that the discussions which have taken place between the Soviet union and the United States, the major nuclear powers, have progressed to the point where there is every reason to believe that agreement may be expected between those two nations.

While there are some problems with regard to certain phases of the agreement, particularly with regard to safeguards, I believe that progress in this whole area should be anticipated. Certainly Canada has been very much engaged in the discussions.
