to the Minister of Transport or to the Governor in Council, and for those reasons I do not want to prejudge the case. I can say, however, that I think hon members will all agree that in the first instance this is a good Canadian company and that it has been providing a worth-while service but that at the same time of course it is vitally important—again I am sure hon members will agree—that passengers' investments be protected. I am sure this is the basic aim of the CTC and I hope they will be able to achieve it.

Hon. Marcel Lambert (Edmonton West): In considering this matter would the minister bear in mind the fact that as a result of the action of the CTC many hundreds of Canadian passengers will be driven to board charter planes just across the border in the United States—

INVESTIGATION OF EFFECT OF FOOD CHAIN PRICE WAR ON SMALL BUSINESSES

Mr. Robert P. Kaplan (Don Valley): Mr. Speaker, I have a question for the Minister of Consumer and Corporate Affairs. Considering the recent reports of sharply declining profits and of losses by the major food chains as a result of the food price war, is the minister considering directing that an investigation be made to determine whether these price wars amount to cut-throat competition designed to eliminate small, independent businesses which compete with the chains?

Hon. Ron Basford (Minister of Consumer and Corporate Affairs): Mr. Speaker, the Director of Investigation and Research under the Combines Investigation Act is of course aware of the price war situation, and if there

should appear to be a breach of that Act he can be expected to take appropriate action.

Hon. George Hees (Prince Edward-Hastings): Mr. Speaker, would the minister tell the House whether he will direct the director to look into this matter and not just leave it up to him to decide whether or not he would like to do so? Would he ask him directly to do it?

Mr. Basford: Mr. Speaker, the director has a statutory duty to enforce the provisions of the Combines Investigation Act and I have every confidence that he will carry out that duty.

TORONTO-PROPOSED SITES FOR NEW FACILITY
