INTERPROVINCIAL MARKETING—REPRISALS BY QUEBEC—DISCUSSIONS BETWEEN FEDERAL AND PROVINCIAL MINISTERS OF JUSTICE

In view of the restrictive measures taken by Ontario with regard to Quebec's FEDCO marketing board for eggs, the Quebec Minister of Justice, Mr. Choquette, has announced that his government would exercise reinforced reprisals against the neighbouring province.

My question is: Has this matter been referred to the Minister of Justice or has he entered into conversations with his Quebec counterpart about this matter?

Hon. John N. Turner (Minister of Justice): No, Mr. Speaker, I did not discuss the matter with the Quebec Attorney General. This question falls in the same category as those recently asked by some Alberta members. The government maintains its position that this problem will be solved with the passing of Bill C-176 by Parliament.

INFORMATION CANADA

REASON THAT FACILITIES NOT USED TO PUBLICIZE CENSUS

In view of the fact that Information Canada was established for the purpose of communicating government plans to the people, will the minister explain why the government felt it necessary to contract out the job of publicizing the census to two advertising firms at a total cost of \$820,000?

Hon. Robert Stanbury (Minister without Portfolio): Mr. Speaker, Information Canada has never been given a mandate to be the spokesman for the government nor to run the government's advertising program.

Mr. Erik Nielsen (Yukon): I have a question for the Prime Minister. When is the Prime Minister going to set aside a day for a debate on the report of the Royal Commission on Security so that we can discuss these matters?

Right Hon. P. E. Trudeau (Prime Minister): When we get to the debate on the resolution now on the order paper on the matter of security and relating to the matter which was dealt with by the Public Order (Temporary Measures) Act, I expect the government will be able to participate in this debate and use the time available to make its views known on the matters covered by the Royal Commission on Security.
