## GRAIN

SHORTAGE OF FEED GRAIN ON VANCOUVER ISLAND— EMERGENCY PLANS IN LIGHT OF CONTINUING STRIKE BY SOME RAILWAY WORKERS

Mr. John Reynolds (Burnaby-Richmond-Delta): Mr. Speaker, my question is for the Minister of Labour. In view of the continuing rail strike in British Columbia, has the government any emergency plans to get feed grain to Vancouver Island to solve the very serious problems of the poultry and dairy industry in that area?

Hon. John C. Munro (Minister of Labour): Mr. Speaker, as the hon. member may be aware, the only hold-out situation is in the city of Vancouver proper and certainly not in British Columbia generally by any means. Prince Rupert is open, and I am hopeful that by the time this day is over the situation in Vancouver may be clarified. In that sense the hon. member's question may, hopefully, be premature.

SHORTAGE OF FEED GRAIN ON VANCOUVER ISLAND— REQUEST THAT EXPORT SUPPLIES BE MADE AVAILABLE AT DOMESTIC PRICES

Mr. John Reynolds (Burnaby-Richmond-Delta): Mr. Speaker, I have a supplementary question for the Minister in charge of the Wheat Board. In view of the fact there is already feed grain on Vancouver Island meant for export, will the minister give the Wheat Board a directive to sell this feed grain already on Vancouver Island at domestic prices instead of export prices in order to solve the very serious problem of the poultry and dairy industries?

Hon. Otto E. Lang (Minister of Justice): I will not purport to give the Canadian Wheat Board such a directive. It has already on its own initiative been making grain available which had been intended for export and holding it where it seemed that it was needed for the domestic situation, but of course it has to protect the grain producers as well in terms of the prices it charges.

VICTORIA, B.C.—POSSIBLE TRANSFER OF HOSPITAL FROM FEDERAL AUTHORITY—REQUEST FOR CONSIDERATION OF VIEWS OF VETERANS

PREVENTION OF RENT INCREASES FOLLOWING
INCREASES IN OLD AGE SECURITY AND GUARANTEED
INCOME SUPPLEMENT PAYMENTS

Mr. Elmer M. MacKay (Central Nova): Mr. Speaker, I have a question for the Minister of State for Urban Affairs. Has the minister, following the increases in OAS and GIS payments, developed measures, either independently or in co-operation with the provinces, to contain and discourage rent increases in order to protect the recipients of these pensions from having their slight increases appropriated by landlords, which has happened often in the past? If so, will these measures be made public soon?

Hon. Ron Basford (Minister of State for Urban Affairs): Mr. Speaker, in respect of those properties owned by CMHC there has been a rent freeze in effect since early this year. In respect of those under the control of the provincial housing authorities, in which we bear part of the cost of any rental subsidy, most have been under a freeze for quite some time. Having regard to those that are privately owned, of course we have no direct authority over them and any control would rest with the provinces.
