MANOIR KIRKLAND, KIRKLAND, QUE.

Question No. 2,409-Mr. Herbert:

- 1. Did the Canada Mortgage and Housing Corporation acquire the Manoir Kirkland, Kirkland, Quebec and, if so, on what date and at what cost?
- 2. Was the property sold and, if so (a) to whom (b) on what date (c) at what price?
- 3. (a) How many apartments are in the buildings (b) were the occupants eligible for a rent subsidy and, if so, was an agreement concluded to continue the subsidy (c) in what manner were the occupants notified of the change of ownership?
- Hon. Paul J. Cosgrove (Minister of Public Works): I am informed by Canada Mortgage and Housing Corporation as follows:
- 1. Yes, CMHC acquired the "Manoir Kirkland" project on December 12, 1979, and the claim paid for its acquisition was \$5,564,300.
- 2. (a), (b) and (c). The "Manoir Kirkland" project was sold to Acquilini Investors Group on September 1, 1980, at the market price of \$3,194,000.
 - 3. (a) 198 apartment units.
 - (b) No, all tenants were paying market rents.
 - (c) Occupants were notified of the sale of the project by individual letters delivered simultaneously with the usual letter of introduction of the new owner/landlord.

POSTAL SERVICE DELIVERY DELAYS

Question No. 2,423—Mr. Cossitt:

- 1. Did the Postmaster General receive a letter from the hon. member for Leeds-Grenville enclosing evidence of correspondence mailed on April 9, 1981 in Toronto to the member and received 13 days later at the House of Commons and, if so (a) what are the reasons for this type of postal service (b) for what reason did it take 13 days for a first-class mail item to travel from Toronto to Ottawa?
- 2. Did the minister receive other complaints of a similar nature and, if so, what action was taken to deal with the complaints?
- Mr. Gary F. McCauley (Parliamentary Secretary to Minister of Consumer and Corporate Affairs and Postmaster General): 1. Yes. (a) and (b). First, it should be explained that with the exception of those registered, records are not maintained for individual pieces of mail. For this reason, we are often unable to determine precisely why or where most irregularities occur. In addition, the cover provided did not bear any endorsements or markings which might indicate the handling accorded and furnish some clues to the reason for the late delivery.
- 2. Yes. Unfortunately, inquiries into individual cases of delay where the cover or envelope bears no indication of abnormal handling generally prove fruitless. Nevertheless, we

The final report should be ready in the spring of 1982. The cost of the survey, which employs more than 180 previously unemployed physical education graduates across the country, will be \$2.9 million.
