The Ontario Assembly is not the constitutionally appointed arena for legal discussion. We have a Court of Appeal in this province and a Supreme Court of the Dominion, and therefore any controversy regarding judicial utterances on the floor of the House is not only improper but grossly impertinent, more especially when a particular case is yet *sub judice*. There is no justification for interference with the McLAREN and CALDWELL case under these circumstances.

The Ontario Legislature may under the provisions of the Act be empowered to alter the law; but it has no right to alter the law, as authoritatively declared from the bench, or to deprive any man of rights which that bench has declared to be his property.
