

"97B. Any person who prints, publishes, edits, issues, circulates, sells, offers for sale or distribution any book, newspaper, periodical, pamphlet, picture, paper, circular, card, letter, writing, print, publication or document of any kind, in which is taught, advocated, advised or defended, or who shall in any manner teach, advocate, advise or defend the use, without authority of law, of force, violence, terrorism, or physical injury to person or property, or threats of such injury, as a means of accomplishing any governmental, industrial or economic change, or otherwise, shall be guilty of an offence and liable to imprisonment for not less than one year, and not more than twenty years.

(2) Any person who circulates or attempts to circulate or distribute any book, newspaper, periodical, pamphlet, picture, paper, circular, card, letter, writing, print, publication, or document of any kind, as described in this section by mailing the same or causing the same to be mailed or posted in any Post Office, letter box, or other mail receptacle in Canada, shall be guilty of an offence, and shall be liable to imprisonment for not less than one year and not more than twenty years.

(3) Any person who imports into Canada from any other country, or attempts to import by or through any means whatsoever, any book, newspaper, periodical, pamphlet, picture, paper, circular, card, letter, writing, print, publication or document of any kind as described in this section, shall be guilty of an offence and shall be liable to imprisonment for not less than one year and not more than twenty years.

(4) It shall be the duty of every person in the employment of the Government of Canada, either in the Post Office Department, or in any other Department to seize and take possession of any book, newspaper, periodical, pamphlet, picture, paper, circular, card, letter, writing, print, publication or document, as mentioned in the last preceding section, upon discovery of same in the Post Office mails of Canada or in or upon any station, wharf, yard, car, truck, motor or other vehicle, steamboat or other vessel upon which the same may be found and when so seized and taken, without delay to transmit the same, together with the envelopes, coverings and wrappings attached thereto, to the Chief Commissioner of Dominion Police."

Mr. Steele, from the Select Standing Committee on Miscellaneous Private Bills, presented the Sixth Report of the said Committee, which is as follows:—

Bill No. 114 (Letter Y2 of the Senate), intituled: "An Act for the relief of Vernon Balm Bailey."

Bill No. 120 (Letter D3 of the Senate), intituled: "An Act for the relief of Eleanor Margaret Webster."

Bill No. 121 (Letter E3 of the Senate), intituled: "An Act for the relief of Jean Donaldson Sifton."

With regard to the two first mentioned Bills (Nos. 102 and 111), your Committee recommend that the additional charge levied on these Bills under Rule 89, subsections 1 (b) and 8, be refunded in each case.
