- 11. Whether there are any initials on the first page of the said memorandum.

12. If so, what they are and what they mean.

13. Whether it appears on the face of the said memorandum that it has been approved.

14. If so, by whom.

15. Whether there was in the form of agreement between the Crown and the banks contained in P.C. 2490 of November 28, 1933, any provision to the same effect as the recommendation to council above mentioned in paragraph 3.

16. Whether the House of Commons sat on June 20, 1934.

- 17. On what exact date the then Prime Minister notified the railway company and the banks that such recommendation had been thus approved.
  - 18. When an Order in Council was passed to ratify such recommendation.
  - 19. When and where first public notice was given of such Order in Council.
