

## Supply—C.B.C.

Not once in all the time I lay there listening to these commentaries did I hear one rightist objective talk about places like Cyprus. I never once heard the fact mentioned that Greece had never been in possession of that land. I never once heard that a great proportion of the population on Cyprus is Turkish. I never once heard it emphasized to the public that if the island and its people were given over to the complete control of Greece, these many thousands of Turkish residents who have just as much right to be there as the Greek residents would be at the mercy of a group of—what shall I call them? I cannot find words to describe them. They are nothing but anarchists who want to gain control by force. What better are they than communists? Not a bit better.

I was lying on my back at home one evening listening to a telecast; I believe it was "Press conference". One of my colleagues, the hon. member for Macleod, was being interviewed by a group of people amongst

whom was Grant Dexter of the *Winnipeg Free Press*. At one stage Mr. Dexter referred to something that had happened just a day or two before in the house concerning my friend the hon. member for Bow River.

During the course of one of his addresses the hon. member for Bow River pulled out a dollar bill and said something to this effect: "Now, what is it that gives value to this?" He referred to the fact that the bill was signed by officers of the Bank of Canada and proceeded to read the names on the dollar bill. He mentioned the name of Mr. Coyne who is the governor of the Bank of Canada. Now this bird, Grant Dexter, up in the gallery, took for granted that he had deliberately mispronounced it, and on the "Press Conference" program to which I have referred he charged—
