I have been in touch with the management of the railway, who advise that negotiations are at present actively under way, but that final arrangements have not yet been concluded.

[Later:]

Mr. Frank Howard (Skeena): Mr. Speaker, first I wish to direct a question to the Minister of Transport. I wonder if he could advise me when the negotiations to which he referred between the Canadian National Railways and this other private concern might be expected to be completed?

Mr. Hees: Mr. Speaker, the management of the Canadian National Railways have advised me that they will be completed just as soon as possible.

CANALS

CHIGNECTO—STATEMENT ON PERSONNEL ENGAGED IN SURVEY

On the orders of the day:

Hon. George H. Hees (Minister of Transport): Mr. Speaker, yesterday the hon. member for Westmorland (Mr. Murphy) asked who are carrying on studies regarding transportation problems in the Atlantic region, and what is the competence of the people who are carrying out this work.

Mr. Murphy (Westmorland): That was not the question.

Mr. Hees: As I understand it, Mr. Speaker, that was the question, and my answer is that this work is being carried out under the direction of the bureau of transportation economics within my department. The staff engaged in this work are the regular employees of that bureau, employed by the civil service commission in accordance with the normal procedures, and selected because of their competence in dealing with economic and other aspects of transportation matters.

I would like to assure the hon. member that I have the greatest confidence in the competence of those who are carrying out these studies, and if he has any doubt as to their competence I suggest he speak to the hon. member for Laurier (Mr. Chevrier) or the hon. member for St. Antoine-Westmount (Mr. Marler) under whose direction these men were appointed to carry out this type of work for my department.

Hon. George C. Marler (St. Antoine-Westmount): I would like to draw the minister's attention to the fact that the question he was asked related to the Chignecto canal and not to transportation problems in general.
