MANITOBA-TEACHERS STILL REQUIRED TO COMPLETE APPLICATION CARDS

Mr. Robert Simpson (Churchill): Mr. Speaker, I had a question for the Minister of Labour but in his absence I will direct it to the Prime Minister. It has to do with the confusion which has been created with regard to requiring teachers to sign social insurance cards, and is related to an answer given in the house by the Minister of Labour last Monday. At that time the hon. member for Queens-Lunenburg asked the minister to make it very clear that it is not an offence for teachers not to complete these cards, and the minister said:

I have made it clear and I shall be glad to make it clear again.

Information I have from the Manitoba teachers' society indicates that up to last Tuesday several school districts in Manitoba were still requiring their teachers to fill out these cards, and that a check of the unemployment insurance office in Winnipeg was made by the Manitoba teachers' society which indicated that that office had received no new letter from Ottawa nor any instructions to prepare a new letter for the districts explaining the error.

Will the Prime Minister assure the house that a statement or directive will go out that will clear up this matter; because apparently Manitoba teachers are still being asked to sign these cards.
