NORTHERN AFFAIRS AND NATIONAL RESOURCES

Mr. Hubert Badanai (Fort William) presented the fifth report of the standing committee on northern affairs and national resources.

Mr. Dinsdale: Mr. Speaker, I rise on a question of privilege. The report of the committee on northern affairs and national resources will have to be received on division; the members of the official opposition dissociate themselves from the report.

Mr. Speaker: Order, please. I understand there is no provision for this, as I am sure the hon. member appreciates. On a question of privilege he may indicate his disagreement with the report, but it certainly cannot be the subject of a debate.

Mr. Badanai: Mr. Speaker, may I be permitted to explain—

Mr. Speaker: Order, please. I suggest to the hon. member that this cannot be done.

Mr. Barnett: On a question of privilege-

Mr. Speaker: Order, please. The Chair has ruled that there is no question of privilege, so the hon. member cannot rise on a question that does not exist.

Mr. Barnett: My question of privilege is different from that raised by the hon. member for Brandon-Souris. My question of privilege is that I failed to hear what report it was that the chairman of the committee on northern affairs and national resources was tabling. I wonder whether he might be allowed to repeat the number of the report, because I think it has some significance.

Mr. Badanai: The report has nothing to do with the matter of—

Mr. Speaker: Order, please. I ask the hon. member's co-operation to indicate to the hon. member for Comox-Alberni the number of the report that he has tabled.

AMENDMENT TO REMOVE FIVE PER CENT REFUNDABLE TAX

FISHERIES ACT

AMENDMENT TO PROHIBIT HUNTING OF SEALS

Mr. Frank Howard (Skeena) moved for leave to introduce Bill No. C-281, to amend the Fisheries Act (seal hunting prohibited).

He said: Mr. Speaker, there are many who support the principle contained in this bill, many with humane instincts and concern about what has taken place in the seal hunting grounds not only this year but in the past. The purpose of the bill is to prohibit anyone from hunting, killing, impeding, injuring or obstructing the progress of seals within the area bounded by the territorial sea of the fishing zones as determined under the Territorial Sea and Fishing Zones Act.
