An hon. Member: Rise and shine.

Mr. David MacDonald (Egmont): Mr. Speaker, I put a somewhat similar question some days ago to the Minister of Transport and he assured me that within a day or two he would be prepared to make a statement both on the rates and on some of the difficulties that have been encountered recently with regard to the C.N.R. operations. Is that being postponed again, or may we expect a statement this week?

Hon. Paul Hellyer (Minister of Transport): I doubt that it will be possible to make it this week, but I hope that we can have this matter settled in a just manner within a few days.

Mr. James A. McGrath (St. John's East): I have a further supplementary question, Mr. Speaker. Is the minister prepared to say to the house whether a decision has been taken to raise the rates on this important service this summer?

Mr. Hellyer: Yes, Mr. Speaker. The answer is no as of now.

INQUIRY OF THE MINISTRY

Mr. Barry Mather (Surrey): Mr. Speaker, I have a question for the Minister of Consumer and Corporate Affairs. Having in mind the fact that this month a great many consumers across the country are having to pay a great deal more money for a much reduced mail service, I wonder whether the minister would investigate those responsible for this situation, possibly starting with the Postmaster General?

INQUIRY AS TO INTRODUCTION OF LEGISLATION

Mr. R. N. Thompson (Red Deer): Mr. Speaker, my question is directed to the Minister of Justice. In view of past assurances by the minister that legislation to amend the Expropriation Act would be introduced to the house this session, can the minister inform the house when this might be?
