#### MANPOWER—APPLICATION FORMS FOR FARMERS SEEKING OFFSHORE WORKERS

Mr. William Knowles (Norfolk-Haldimand): Mr. Speaker, I rise tonight to expand on a question that I asked the Minister of Employment and Immigration (Mr. Cullen) on March 15 relating to offshore labour to assist farmers in my area, fruit and vegetable farmers in particular, and later on tobacco farmers. The question I asked the minister was why the Manpower centres and farm labour pools across Ontario require farmers who apply for offshore labour to sign blank application forms which give Manpower the right to write in wages at a later date without consulting the farmer. The minister said, among other things, one sentence that meant something to me at the time, and it is as follows:

I do not think it is appropriate that they should be signing blank application forms. I will check it out. I thank the hon, member for his representation.

Since then the minister has written me a letter at some length trying to explain exactly what the officials in the Manpower centres have been trying to do. To set the record straight, I should like to read the blank form the farmers were asked to sign. It begins as follows:

THIS IS TO CONFIRM that I understand and agree that the workers I have requested on ORDER NO.....

FOR .....employment

### (crop/occupation)

WILL BE PAID at the prevailing wage levels now being determined by the Canada Employment and Immigration Commission . . .

The farmer is asked to sign that without any wage being stated. Surely the farmer has a right to know what wages he is expected to pay before he signs a document such as that.
