Mr. Lewis: It was the intention of the House that we would give as much time as possible for debate today and this evening. Therefore, I would like to correct the record and have it read that "there have been discussions among the Parties with respect to the final recorded divisions on Bill C-130", which would, under the rules, take place at 9.45 p.m. tonight. I think you will find unanimous consent to defer the recorded divisions on second reading of Bill C-130 until 6 p.m. tomorrow evening.

Mr. Gauthier: Madam Speaker, since I was brought on to the scene, I did bring the matter to the attention of the Hon. Minister. He has my copy which I underlined for him. This morning the Minister made a Freudian slip. It was clear to me that he wanted the final recorded division, but later on he said "the last recorded division". There was no "s" to make the word plural. I took it that it was the main motion that would be put tomorrow night and that we would deal, as we did this morning, with any subamendments or amendments that were before the House prior adjourning tonight. I thought that was the disposition.

Tomorrow, we will be debating Bill C-72 if I understand correctly. Maybe the Minister could confirm that to me. If we are, there may be several votes if the amendments are still on the books. I think it could be a very long evening. He is just adding to tomorrow night's voting patterns.

Mr. Marcel Prud'homme (Saint-Denis): Point of order, Madam Speaker.

The Acting Speaker (Mrs. Champagne): The Hon. Member for Saint-Denis (Mr. Prud'homme) on a point of order.

Mr. Prud'homme: Madam Speaker, I must tell you that I also read the Order Paper for the House this morning, and it is just like—because the Minister knows that it must be unanimous, anyway. That is what I understood this morning, that we would hold all the votes on amendments this evening, today, but that the final recorded division would be tomorrow night. Now, if my whip, not the house leader, but my whip tells me that he agrees, I will give my support, but I still want to say very clearly that this is not what we agreed on today.

I am looking at my whip there and he is busy talking. If my whip tells me that he agrees, I will agree with my whip, but otherwise, I will not give my support. But if my whip tells me that he understood it could be done, I will gladly do so.
