*[English]***CANADIAN SECURITY INTELLIGENCE SERVICE
ACT****MEASURE TO AMEND**

Mr. Tom Wappel (Scarborough West) moved for leave to introduce bill C-355, an act to amend the Canadian Security Intelligence Service Act.

Madam Deputy Speaker: Pursuant to Standing Order 68(2), the motion is deemed adopted.

Mr. Wappel: Madam Speaker, I have a very short explanation. This bill would amend section 52 of the Canadian Security Intelligence Service Act. That is the section which permits the Security Intelligence Review Committee to make certain recommendations in connection with decisions that have been made by, for example, senior bureaucrats.

As a result of the decision of the Supreme Court of Canada and a decision by the Chief of the Defence Staff, it has become obvious that those recommendations are toothless.

This private member's bill is an attempt to give some teeth to the recommendations of SIRC and to provide an opportunity for the minister in Parliament to explain why SIRC's recommendations will not be followed in a particular case.

Madam Deputy Speaker: Mr. Wappel moves that the bill be now read the first time and printed.

Pursuant to Standing Order 69(1), the motion is deemed adopted.

Bill read the first time and printed.
