rent and not tear the building to  
pieces. Today things are changed.  
Positions are exactly reversed, and the  
man who has a house to rent must be  
approached cautiously lest his anger  
be aroused and he be given an excuse  
to raise the rent on the house he is  
about to, or already, rent.
