- (g) To refer to any other body of the Organization any matter within the provisions of the present Convention upon which such body is empowered to act;
- (h) To consider the reports and activities of the Executive Committee and to take such action in regard thereto as the Congress may determine
- (i) To establish Regional Associations in accordance with the provision of Article 18; to determine their geographical limits, coordinate the activities, and consider their recommendations;
- (j) To establish Technical Commissions in accordance with the provision of Article 19; to define their terms of reference, coordinate the activities, and consider their recommendations;
- (k) To determine the location of the Secretariat of the Organization;
- (1) To take any other appropriate action to further the purposes of the Organization.

ARTICLE 8

Execution of Congress Decisions

- (a) All Members shall do their utmost to implement the decisions of t^{μ} Congress.
- (b) If, however, any Member finds it impracticable to give effect to some requirement in a technical resolution adopted by Congress, such Member shall inform the Secretary General of the Organization whether it inability to give effect to it is provisional or final, and state its reason therefor.

ARTICLE 9

Meetings

Meetings of the Congress shall be convened by decision of the Congress or of the Executive Committee at intervals not exceeding four years.

ARTICLE 10

Voting

The provisions of this votes cast. The provisions of this paragraph, however, shall not apply to decisions taken in accordance with a paragraph, however, shall not apply to decisions taken in accordance with Articles 3, 25, 26 and 28 of the present Convention.
