Pursuant to the Order of the Day, the following Petitions were severally read :—

Of the Municipal Council of the County of Victoria, in the Province of Ontario; praying for the passing of such legislation as will immediately restore the laws affecting the making and keeping in repair of cattle-guards on railways as they existed in 1886.

Of the Great Eastern Railway Company; praying for the passing of an Act extending the time for the completion of the construction of their Railway.

Of the County Council of the County of Carleton, in the Province of Ontario; of the County Council of the County of Halton, and of the Municipal Corporation of the Council of the County of Victoria, in the Province of Ontario; all severally praying for the passing of such legislation as will more fully control the speed of trains travelling over Railway Crossings, and for other purposes.

Of the Edmonton and Slave Lake Railway Company; praying for the passing of an Act extending the time for the commencement and completion of the said Railway.

Of George Duncan Wood and others, of the City of Winnipeg, in the Province of Manitoba; praying for the passing of an Act incorporating them as "The Battleford and Lake Lenore Railway Company."
