In view of the fact that the initial policy announced a year ago on October 3, 1965, by the then minister of labour was in favour of the opening of a new mine at Lingan, which he said would constitute an essential part of the new program, and in view of the fact that this was reiterated by the now Minister of National Health and Welfare on October 3, 1966, in Cape Breton, and in view of the fact that the Donald report says that the opening of a new mine—
