RESEARCH STUDIES ON LABOUR RELATIONS

Motion No. 86—**Mr. Orlikow:**

That an Order of the House do issue for a copy of each of the research studies commissioned and completed by and for the Labour Relations Task Force.

Hon. Donald S. Macdonald (President of the Privy Council): Mr. Speaker, these documents fall into two categories. As was previously announced the government has decided in due course to publish approximately 20 of these studies. These are to be published by the Queen's Printer. The government would be quite agreeable to these being tabled at once, subject only to the understanding that the reports when ultimately published may contain the normal prepublication editorial changes with regard to grammar, references and reorganization of material.

The second category of studies includes those which the government has itself decided not to publish, but under the arrangement the authors were entitled to make their own private arrangements for publication. Leaving aside the question of copyright, the motion would be acceptable subject only to obtaining the consent of the authors in question to have them published. If the hon. member is in a position to accept those two bases we would be in a position to honour his notice of motion.

Mr. David Orlikow (Winnipeg North): It is agreeable.

Mr. Speaker: Subject to the reservations and conditions expressed by the minister, is it the pleasure of the house that notice of motion No. 86 be deemed to have been adopted?
