CANCER RESEARCH

- Mr. J. A. Jerome (Parliamentary Secretary to President of the Privy Council): I am informed by Statistics Canada and the Department of National Health and Welfare as follows: 1. Statistics on the number of deaths due to lung cancer are collected on a calendar year rather than fiscal year basis. For the 1970 calendar year there were 5,048 deaths due to lung cancer.
- 2. Under the National Health Grant program, \$350,000 was paid directly to the National Cancer Institute for cancer research. This does not include the grants of the Medical Research Council.
- 3. More than \$4,000,000 for the period 1948-49 to 1970-71, from the Department of National Health and Welfare.
