### AIR TRANSPORT

LOSS OF DEPOSITS BY CUSTOMERS OF CHARTER FLIGHT INFORMATION SERVICES

Mr. John Gilbert (Broadview): Mr. Speaker, I have a question for the Minister of Transport. In view of the business failure of an air charter firm in Toronto known as Charter Flight Information Services, resulting in the loss of deposits by many customers, what action will the minister be taking to have the deposits returned to the customers, and what protection do air charter passengers have in such cases?

Hon. Donald C. Jamieson (Minister of Transport): Mr. Speaker, I will have to take that question as notice as to detail. Protection, of course, is provided if the carrier is one licensed by the Canadian Transport Commission, but I do not know what the specific circumstances are in this case.

### POST OFFICE

POSITION OF NEGOTIATIONS WITH UNIONS ON NEW CONTRACT

### PLANS TO REDUCE STRIKES

In light of the fact that the President of the Treasury Board has accepted a policy of reducing strikes in the Public Service rather than withdrawing the right to strike, can he advise the House when he will in fact be laying on the table the policy and the plans with regard to that attitude of the President of the Treasury Board and whether in fact this follows from the Bryden report?

Hon. C. M. Drury (President of the Treasury Board): Mr. Speaker, it is not my intention and, indeed, it is not my hope to lay before the House a policy on what the hon. gentleman calls strike reduction. I must confess I do not quite understand that. In so far as the so-called Bryden report is concerned, I think the House leader has already made reference to that at an earlier date.

Mr. Speaker: Order, please. The hon. member wishes to ask a further supplementary but if he will look around him he will see there are many hon. members who are anxious to ask questions and we are running short of time. For the moment the Chair might be allowed to recognize the hon. member for Richmond.
